उपरोक्त विषयाच्या संदर्भात कळविण्यात येते की, आपण संदर्भिय पत्रान्वये या कार्यालयास सादर केलेल्या आपल्या महाविद्यालयाचे सन २०१२-२०१३ या वर्षाचे दिनांक १ ऑक्टोबर २०१२ रोजीच्या अनुदानित विद्यार्थी संख्येच्या बरोबर असल्या बाबत आपण प्रमाणित केले आहे. त्याआधारे आपल्या महाविद्यालयाचा विषयनिहाय /विद्याशाखांनिहाय कार्यभार तपासणी करून शासनाने वेळोवेळी निर्गमित केलेल्या शासन निर्णयाच्या अधिन राहून तसेच शासन निर्णय दिनांक ११.१२.१९९९ अन्वये विहित केलेल्या कार्यभाराच्या मानकानुसार खालील अटीच्या अधिन राहून शिक्षक / शिक्षकेतर पदे सोबत दिलेल्या तक्त्याप्रमाणे मान्य करण्यात येत आहे.
